STUDENT IDENTIFICATION POLICY

1. INTRODUCTION

1.1 BARBRI Global Limited, (the "Company", "they") deliver higher education courses internationally, with a particular focus on the Solicitors Qualifying Examination ("SQE") in the UK and the State Bar Exam in the US. The courses provided by the Company are taken online and as such they do not currently request identification when students are enrolling on the courses.

2. GENERAL

- 2.1 As a rule, students are not required to provide identification to enrol on any of the Company SQE courses.
- 2.2 At the point of enrolment, the onus is on the student to ensure they are enrolling onto the correct course with consideration for their own eligibility based on their qualifications.
- 2.3 From time to time, the Company may request documents that establish student's identity and / or credentials for the award of scholarships, alumni partner discounts, confirmation of enrolment letters, etc.
- 2.4 There is no set combination of documents required to confirm identity and / or credentials, instead this is based on the nature of the specific request. The Company has full discretion to request additional documentation where there appears to be a gap in information provided. All documents will be processed in accordance with the terms set out in our data protection policy.

3. SCHOLARSHIPS

- 3.1 The Company Scholarship Programme is an initiative aiming to offer students a chance of passing SQE1 regardless of their personal circumstances.
- 3.2 The Company have created four different types of SQE scholarships to target students of all social backgrounds. Each of these is designed to provide the legal industry professionals of the future with a route to successfully passing the SQE.
- 3.3 Some of the scholarships offered require applicants to provide a combination of documents to confirm identity and / or credentials. All scholarship requirements are set out on the Company website for candidates to review before applying for a specific scholarship.
- 3.4 The BARBRI Humanitarian SQE Scholarship is open to applicants who can prove asylum / refugee status or displacement due to war. The applicant will be required to provide documentation evidencing their status. Each application is unique and assessment and requested documentation will be on a case-by-case basis.
- 3.5 The Public Sector SQE Scholarship is open to applicants who can show that they are employed or committed to be employed in the public interest sector with an annual salary less than £45,000. The applicant will be required to describe their public interest work and attach a resume evidencing such work, supply a formal offer of public interest sector employment, or provide evidence of participation in a school sponsored public interest scholarship / fellowship program.
- 3.6 The First-Class Honours SQE Scholarship is open to those who have achieved a first-class honours in their undergraduate degree (or international equivalent to a UK first class degree). The applicant will be required to provide a copy of their degree transcript and degree certificate to prove first class honours classification and the level of degree obtained.

4. PARTNER ALUMNI DISCOUNTS

- 4.1 The Company have built several preferred and exclusive partnerships with law firms, ALSPs and universities to provide their aspiring lawyers with everything they need to excel.
- 4.2 As part of the ongoing collaboration, the Company offers several SQE discounts to applicants coming from one of the selected partners. Those wishing to benefit from a specific discount, will be required to provide documentation to prove alumni / employee status, e.g., by providing a copy of a degree transcript or degree certificate, letter of employment, etc.

5. CONFIRMATION OF ENROLLMENT LETTERS

- 5.1 The Company does not provide academic references; however, students can request a letter from the Student Services Team confirming the course type, duration and session undertaken by the specific student.
- 5.2 Unless the student or requesting third party require additional information, the student will not be required to provide additional identification.
